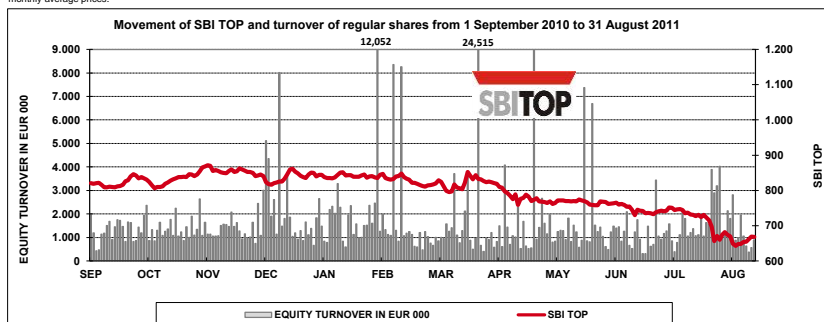

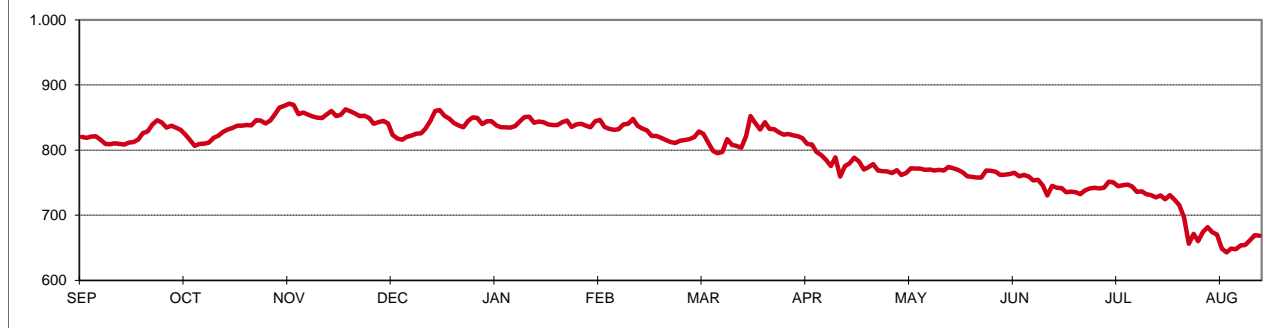

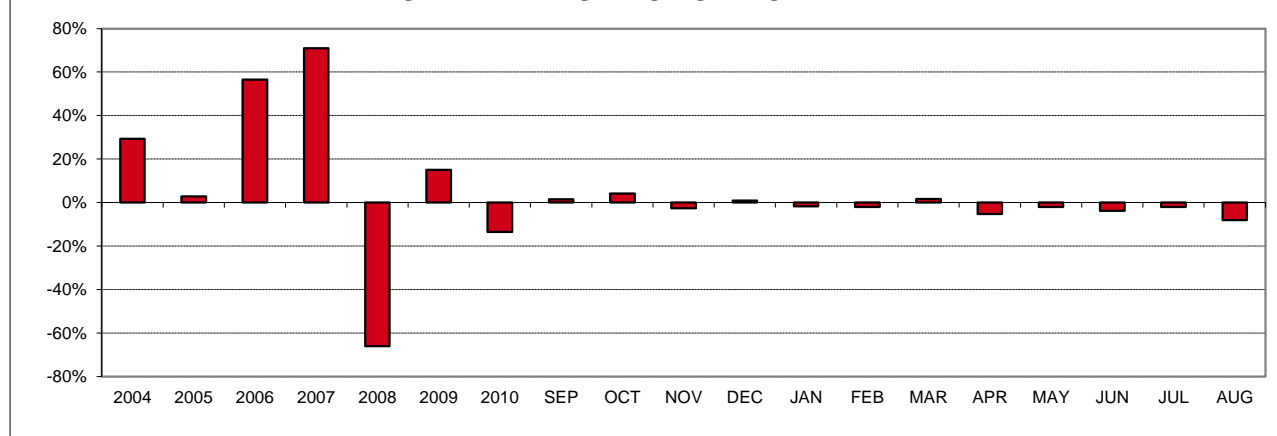

SBI TOP INDEX FROM 1 SEP 2010 TO 31 AUG 2011



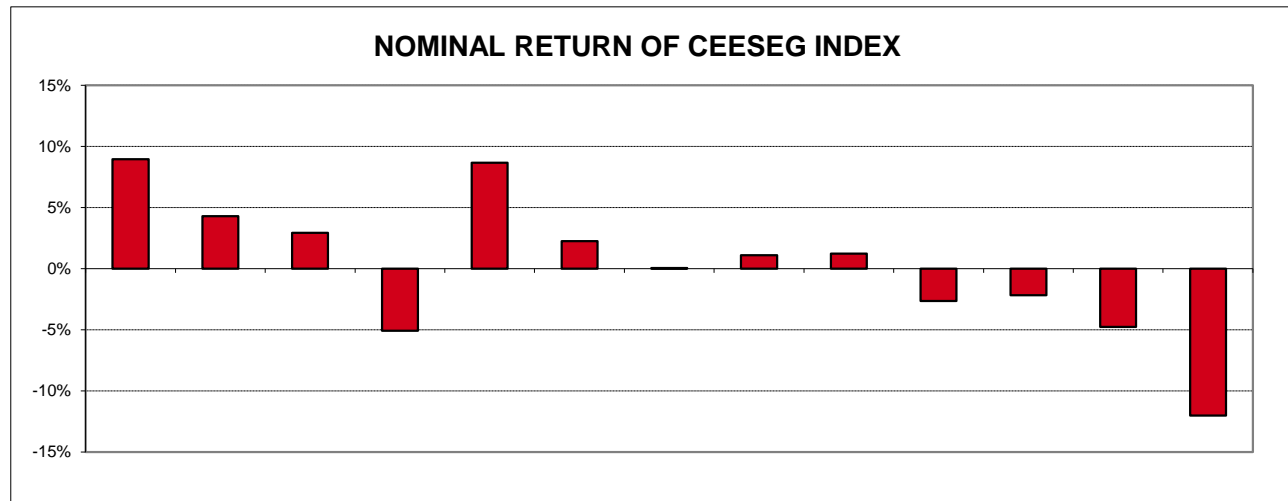
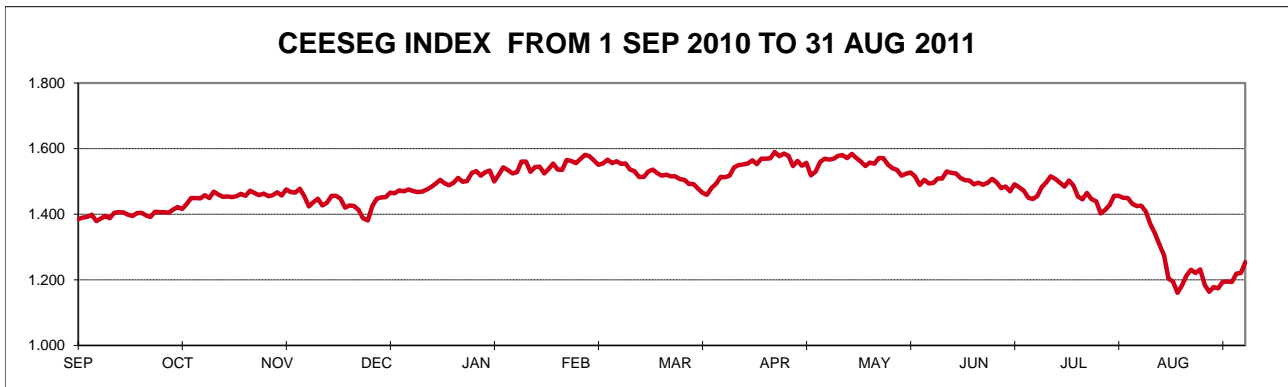
NOMINAL RETURN OF SBI TOP INDEX
